As per reference 1st cited, the Government have issued NOC to start B Sc Nursing Course in St. Joseph’s College of Nursing, Mukkom, Kozhikode attached to the Medical Sisters of St. Joseph Society. As per reference 2nd cited, the Principal has remitted prescribed fees and requested for starting B.Sc. Nursing Programme.

Based on the application an inspection team consisting of qualified faculty members conducted inspection at the institution and has submitted the report vide reference (3) above. The inspection report was scrutinized by the scrutiny committee and is pending approval of the council. Vide letter read (4) above, Government has directed to issue Conditional Affiliation to Nursing Colleges whose inspection has been completed.

As per the reference 5th cited, the Principal submitted Compliance report

Now the Ex-officio president has directed to give Conditional affiliation to new Nursing College also whose inspection has been completed.

In the above circumstance, sanction is accorded to the Principal, St. Joseph’s College of Nursing, Dharmagiri St. Joseph’s Hospital, Agustianmuzhi, Mukkom, Kozhikode to start College of Nursing to conduct B. Sc. Nursing Programme during 2025-26 **with an annual intake of 50 students.**

The Management should strictly follow the guidelines of the Government and the University for conducting the Programme. The management should also follow strictly the norms prescribed by the Indian Nursing Council and the Kerala Nurses and Midwives Council for conducting the Programme. **The Management should obtain affiliation from the Kerala University of Health Sciences, Thrissur and Letter of Permission from the Government before admitting the students during 2025-26.** The Management should obtain separate order from the Kerala Nurses and Midwives Council to admit the next batch of students during the academic year 2026-27. The management is required to adhere strictly to the guidelines issued by the Government, the Indian Nursing Council and the Kerala Nurses and Midwives Council for conducting the Programme. The admission should strictly be in accordance with the Seat Matrix issued by Government of Kerala for the year 2025-26, failing of which, the conditional affiliation granted will be withdrawn
