### ORDER

The University vide paper read (1) above, had invited applications for Continuation of Provisional Affiliation for the Academic Year 2026-27 from the colleges affiliated to the University. Accordingly, the Principal of St.Joseph's College of Nursing Mukkam,Kozhikkode, had submitted the application for Continuation of Provisional Affiliation to conduct for the following course: B.Sc. Nursing (50 seats),

2.Accordingly, University conducted inspection at this institution in order to verify the facilities available for granting Continuation of Provisional Affiliation for the academic year 2026-27. The scrutiny committee after verifying the inspection report, reported no deficiencies in the College and hence recommended to grant Continuation of Provisional Affiliation to the same college for conducting the B.Sc. Nursing course with intake of 50 seats during the academic year 2026- 27.

3.St.Joseph's College of Nursing Mukkam, Kozhikkode was given conditional provisional affiliation for the academic year 2025-26 for BSc Nursing 50 seats on a condition that the institution shall clear the legal verification pertaining to land and ownership within six months. Legal verification is not completed yet.

4.In these circumstances, considering the urgency of the admission process for nursing courses and based on the recommendation of the Scrutiny Committee, as per Statute 2(5)ix(16) of the First Statute amended on the matter of affiliation, sanction is hereby accorded to grant Conditional Continuation of Provisional Affiliation to the **St.Joseph's College of Nursing Mukkam,Kozhikkode for conducting BSc Nursing 50 seats for the academic year 2026-27**. This is subject to ratification by the Governing Council and in anticipation of KNMC & INC approval for the academic year 2026-27. If the intake is reduced either by KNMC or INC the number of seats to which admissions can be made should be reduced accordingly. The Conditional Continuation of Provisional Affiliation 2026-27 granted now is subject to the following specific conditions:

**i.The institution shall clear the legal verification pertaining to land and ownership within three months.**

ii.The college shall provide an undertaking on stamp paper worth Rs. 500/- to the University within seven days from the date of receipt of this order. This undertaking shall state that "the loss suffered by the students admitted to the college shall be compensated by the college as determined by the University, in the event of this conditional Continuation of Provisional affiliation not being made absolute due to the failure by the college in fulfilling the conditions stipulated herein." Failure to submit this undertaking within the stipulated time shall render the Conditional Continuation of Provisional Affiliation null and void.

iii.If the conditions mentioned above are not satisfied within the specified period, the Conditional Continuation of Provisional Affiliation now granted shall automatically cease, as stipulated in the affiliation statute 2 (5) ix (16).





5.The colleges shall strictly adhere to the general conditions detailed below :

- i) Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Government of Kerala and on the basis of the directions issued by the University from time to time, failing which the Affiliation granted will be cancelled.
- ii) In the light of the direction of the Supreme Court of India in Writ Petition (c) 56/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of Affiliation of the College will be initiated.
- iii) Affiliation granted is strictly provisional and is only for the Academic Year 2026-27. The college has to apply for Continuation of Provisional Affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex body concerned.
- iv) Admission to the next academic year shall be made only after obtaining prior permissions from the University.
- v) The colleges should submit approval orders from INC and KNMC for the year 2026- 27.
- vi) The Colleges should admit students to the Management seats in accordance with the Govt. of Kerala's Seat Matrix, only after the issuance of seat matrix from Govt. of Kerala published for the Academic year 2026- 27
